Motion was made by CF to transfer up to \$10,000 from Article 1 to Article 7. Seconded by TC. Motion passed 7/0.

RC made the motion to approve the dates. IC seconded the motion. Motion passed 7/0. Note that the decision was made to hold ALL the meetings at MJHS. More centrally located and convenient for technology.
