
Emails/Phone Calls

Title 1 Policy Statement:

Any parents may request teacher professional qualifications for any teacher in the school. Requests should be made in writing to the building principal.

School Compact:

The Title 1 School-Parent Compact is disseminated to all parents. As part of our compact, parents are asked to provide home/school connections to ensure their child's success. Through the Title 1 program, parents will be invited annually to review and revise our School-Parent Compact.

Communication:

Parents will receive reports informing them of their child's academic progress. Parents are informed of and invited to activities throughout the year that give them a better understanding of what is expected of their children and the type of instruction their children are receiving. Parents are given tools to work with their children in the areas of reading and math. Activities that occur to meet the school's Title 1 parent involvement requirements are:

At year end, a survey will be distributed to all parents for feedback on the Title 1 program services that have been provided to them and their child. This survey is one method in which parents assist the school in the planning, reviewing, and improvement of the Title 1 program.

Parent/Teacher Conferences

Parent/Teacher conferences are held yearly in October. Parents make an appointment to meet with their child's teacher to discuss his/her progress. The Title 1 staff provides information on conference days to help build parent capacity to work with their children and to foster parent involvement.
